

Send 'letter of instruction' to your State legislator(s) demanding that they introduce "A Bill to investigate the Legality of the Action of Federal agents with Regard to the United Nations Organization". Attach sample bill.

Enclosure of the following SUPPORTING DOCUMENTS with your 'letter' is recommended.

a. SHOULD THE UNITED STATES PARTICIPATE AND ENCOURAGE DEVELOPMENT OF THE UNITED NATIONS ORGANIZATION. Recorded debate between Congressman Richard Ottinger, Director, United States Committee on the United Nations, and Archibald Roberts, Director, Committee to Restore the Constitution.

b. PERPETUAL WAR FOR PERPETUAL PEACE

c. UNITED NATIONS THREAT TO SOVEREIGNTY, A Study by the Alabama Legislative Commission to Preserve the Peace.

NOTE: "Full Faith and Credit shall be given in each State to the public Acts, Records and Judicial proceedings of every other State". Constitution of the United States, Art IV, sec 1.
